Subject: Direction Under NGT Case No 606/2018 Compliance of Solid Waste Management Rules 2016

Ref: NGT order dated 16/04/2019 in case no 606/2018.

With reference to above cited subject. Chief Secretary of State Rajasthan appeared in person on 16/04/2019 at Principal Bench NGT (New Delhi) and submitted action taken report incompliance of O.A. 606/2018. It is very sad that after repetitive attempts with each ULB, very few ULB's are following the NGT Order (O.A. 606/2018 on 16.01.2019) circulated by the department (Also uploaded on Google Drive).

In this matter, it is further directed that each ULB shall ensure the compliance of

following points strictly:-

- L As per NGT order dated 16.04.2019 para no 22(a), 43 (i): Municipalities shall start the compliance of Solid Waste Management Rules 2016 (From DPR preparation to Processing and Disposal of Waste), Plastic Waste Management 2016 Rules (From collection to Disposal of Plastics and given in rules) and Biomedical Waste Management Rules 2016 immediately and send the compliance report of 18 Points suggested by NGT order dated 16.01.2019 & 16.04.2019 in prescribed timing as uploaded on Google drive.
- As per NGT order dated 16.04.2019 para no 22(e): Municipal Corporation Kota.
 Municipal Board Keshoraipatan, RUIDP and UIT Kota shall work and send the compliance report under case 673/2018 " More River stretches are now critically polluted" as directed in respective NGT order and direction issued to ULB for timely uploading on Google drive.
- 3. As per NGT order dated 16.04.2019 para no 22(d): Municipal Corporation/Council Jaipur, Jodhpur, Kota, Udaipur and Alwar shall work and send the compliance report under case 681/2018 "NCAP with Multiple timeline to clear air in 102 Cities to be released around 15 August" as directed in respective NGT order and direction issued to ULB for timely uploading on Google drive.
- As per NGT order dated 16.04.2019 para no 22(g): Each ULB's shall send the details
 of penalty collected by the polluters in respective cased under polluters pay
 principles, Precautionary principle and details of utilization of funds collected.
- As per NGT order dated 16.04.2019 para no 22(h): Jaipur, Udaipur, Sikar are selected as model cities and Pushkar. Dungarpur and Pratapgarh are selected as model

town in Rajasthan (Urban). All these municipalities shall submit the work done to DLB in each month and they should complete the implementation of solid waste management rules 2016 before 24/07/2019.

- As per NGT order dated 16.04.2019 para no 24: All ULB's shall display the progress done by them in NGT order 606/2018 at their respective websites with updated at each month.
- As per NGT order dated 16.04,2019 para no 07 (iii & iv). For development of the works related to SWM 2016 all the Municipalities shall use first their funds for all the work and then utilized the state funds.
- As per NGT order dated 16.04.2019 para no 08 (vii & iv). Jaipur and Jodhpur Municipal Corporation shall ensure the proper segregation before the establishment of Waste to Energy Plant.
- As per NGT order dated 16.04,2019 para no 08 (x(v)). It is mandatory in the part of concessionaire/operator (who is collecting the waste in city) to segregate the C&D waste and Inert waste and then transport to landfill site.
- 10 As per NGT order dated 16.04.2019 para no 08 (xx): Municipalities will ensure that there will be no burning of Waste in the area and for each such incident penalty should be taken as 5000 Rs (for simple burning) and 25000 Rs for bulk waste burning.
- 11. As per NGT order dated 16.04.2019 para no 08 (xxvi) & para No 11: All ULB's shall note that no dumping site provision is there in the MSW Rules 2016. All the dumping site shall closed and Sanitary landfill site should be developed. ULB shall have a system for treatment of Legacy waste with different technologies. (Udaipur Municipal Corporation started the treatment)

In this regard it is mandatory for each ULB's to follow the direction as given by NGT in the time bound manner. Strict Action will be taken against the Commissioner/ Executive officer of respective ULBs (As per para No 8 point no iv) if they full to implement the above direction given by Hon'ble NGT.

Also all the DDR's of concerned division shall monitor the implementation of above said rules and order passed by Hon'ble NGT.
