NOTIFICATION

In exercise of the powers conferred by section 43 read with section 337 of the Rajasthan Municipalities Act, 2009 (Act No. 18 of 2009), the State Government hereby makes the following rules further to amend the Rajasthan Municipalities (Election) Rules, 1994, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Municipalities (Election) (Third Amendment) Rules, 2019.
- (2) They shall come into force on and from the date of their publication in the official Gazette.
- 2. Amendment of rule 78-A.- In rule 78-A of the Rajasthan Municipalities (Election) Rules, 1994, hereinafter referred to as the said rules,-
- (i) in sub-rule (1), for the existing expression "in accordance with the provisions of the foregoing rules contained in this chapter", the expression "in accordance with the provisions of rules as existed at the time of election of the Chairperson who vacated the office", shall be substituted;
 - (ii) the existing sub-rule (2) shall be substituted by the following, namely:-
- "(2) The date for such bye-election shall be fixed by the State Election Commission."
- 3. Amendment of rule 95.- In rule 95 of the said rules, for the existing expression "in accordance with the provisions of the foregoing rules contained in this chapter", the expression "in accordance with the provisions of rules as existed at the time of election of the Vice-Chairperson who vacated the office", shall be substituted.
