No. F.8(G)(Rules)/DLB/2015/4081:- In exercise of powers conferred under section 337 read with section 73 of the Rajasthan Municipalities Act, 2009 (Act. No. 18 of 2009), the State Government hereby makes the following rules further to amend the Rajasthan Municipalities (Purchase of Material and Contracts) Rules, 1974, namely:-

1. Short title and commencement. (1) These rules may be called the Rajasthan Municipalities (Purchase of Material and Contracts) (Amendment) Rules, 2015.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 14.- The existing sub-rule (1) of rule 14 of the Rajasthan Municipalities (Purchase of Material and Contracts) Rules, 1974 shall be substituted by the following, namely:-

"(1) No contract shall be entered into for the purchase of material/goods or for the execution of work without the prior administrative and financial sanction/ approval of the following authorities:-

(A) In case of Municipal Corporation

(1) Expenditure upto Rs. 10.00 Lacs

(2) Expenditure upto Rs. 100.00 Lacs

(3) Expenditure upto Rs. 200.00 Lacs

(4) Expenditure upto Rs. 500.00 Lacs

(5) Full Powers upto Budget Provision

(B) In case of Municipal Council

(1) Expenditure upto Rs. 2.00 Lacs.

(2) Expenditure upto Rs. 50.00 Lacs.

(3) Expenditure upto Rs. 100.00 Lacs

(4) Full Powers upto Budget Provision

(C) In case of Municipal Board

(1) Expenditure upto Rs. 1.00 Lacs

(2) Expenditure upto Rs. 25.00 Lacs

(3) Expenditure upto Rs. 50.00 Lacs

(4) Full Powers upto Budget Provision

Provided that the authorities specified under clause (A),(B) and (C) above, shall exercise the powers subject to the provisions of section 81 of the Act and if amount exceeds at any time by more than twenty percent plus the actual income and expenditure of the previous year, then,-

(i) the authorities specified under clause (A) and (B) shall obtain previous approval of the State Government; and

(ii) the authorities specified under clause (C) shall obtain previous approval of the Deputy Director (Regional)."
