No. F.8(G)(Rules)/DLB/2015/4081:- In exercise of powers conferred under section 337 read with section 73 of the Rajasthan Municipalities Act, 2009 (Act. No. 18 of 2009), the State Government hereby makes the following rules further to amend the Rajasthan Municipalities (Purchase of Material and Contracts) Rules, 1974, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Rajasthan Municipalities (Purchase of Material and Contracts) (Amendment) Rules, 2015.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. **Amendment of rule 14.**- The existing sub-rule (1) of rule 14 of the Rajasthan Municipalities (Purchase of Material and Contracts) Rules, 1974 shall be substituted by the following, namely :-

"(1) No contract shall be entered into for the purchase of material/goods or for the execution of work without the prior administrative and financial sanction/ approval of the following authorities:-

The Authority shall for the purpose of protection and development of the lakes carry out all the functions entrusted to it by the Rajasthan Lakes (Protection and Development) Authority Ordinance, 2015.

The Authority shall carry out the survey of lakes and send its recommendations to the State Government for declaration of Lakes boundaries and protected area.

4	Chief Executive Officer of Zila Parishad	-	Member
5	Conservator of Forest or his nominee not below the rank of Deputy Conservator of Forest. In case there are more than one officer of this rank posted, concerned CCF shall nominate one officer from among them to this Committee.	-	Member
6	Superintending Engineer of his nominee not below the rank of Executive Engineer of Water Resources Department	-	Member
7	Nominee of Director, Tourism Department	-	Member
8	Nominee of Director, Fisheries department	-	Member
9	Nominee of Member secretary of Rajasthan Pollution Control Board	-	Member
10	Two experts nominated by the State Government	-	Member

The Committee shall carry out following functions:-

1. The Committee Shall Carry out Survey of the lakes and prepare proposals for declaration of Lake Boundaries and Protected Area, prepare plans, projects and schemes for Protection and development of lakes and submit it to Authority with its recommendations.
2. The Committee shall take all steps to prevent and stop unauthorised activities with in the lake boundaries and the protected area.
3. The Committee shall take all steps to prevent and stop unauthorised construction in the protected area.
