At the outset, Member Secretary, Rajasthan State Pollution Control Board, Jaipur welcomed the members of the Board. Thereafter, the agenda items were discussed and following decisions were taken:

### Agenda Item No. 148.01: Confirmation of minutes of 147th Board meeting

After discussion on the agenda item, the Board members resolved as follows:

#### **Resolution:**

148.01: Resolved that the minutes of the 147<sup>th</sup> meeting are approved.

#### Agenda Item No. 148.02: Compliance of decisions taken in 147th Board meetings 2.

#### **Resolution:**

148.02: After discussion on the agenda item, the Board members resolved that item No. 147.01 to 147.09 and item no 147.11 to 147.13 may be dropped as action has been completed on these items. The Board members advised to take further action on the remaining agenda items. As regarding agenda item no.139.26, it was decided to close the project as the project has been completed and the PP may submit new project proposals in case additional funding is required. As regarding item no. 147.10, it was decided that the matter may also be referred to the State Government for approval under RAPSAR Act.

3. Agenda Item No. 148.03: Approval of waiver of fee for registration of battery dealers under Rule 7 of the Battery (Management and Handling) Rules, 2001.

#### Resolution:

148.03: The Board perused the contents of the office order dated 31.12.2020 and resolved to accord ex-post facto approval for waiver of fee with applications for registration of battery dealers under Rule 7 of the Battery (Management and Handling) Rules, 2001 till 31.03.2021. The matter was further discussed and it was decided that looking to small number of applications received so far for registration under the Rules, the fee waiver may further be extended till 30.06.2021. However, no further, extension in fee waiver should be considered beyond 30.06.2021.

4. Agenda Item No. 148.04: Approval of "Guidelines & Format for submission of Research & Development project for financial support".
