Sub: Directions under section 33A of the Water (Prevention and Control of Pollution) Act, 1974 and 31A of the Air (Prevention and Control of Pollution) Act, 1981.

- 1. Whereas the Water (Prevention and Control of Pollution) Act, 1974 & Air (Prevention and Control of Pollution) Act, 1981 (hereinafter referred to as the "Acts") have come into force in whole of the country, with effect from 23.03.1974 & 16.05.1981, respectively.
- 2. And whereas the Acts have been enacted to provide for the prevention, control and abatement of water & air pollution and for maintaining and restoring the wholesomeness of water & air.
- 3. And whereas under the provisions of section 24 of the Water Act, no person shall knowingly cause or permit any poisonous, noxious or polluting matter, determined in accordance with such standards as may be laid down by the State Board, to enter into any stream or well or sewer or on land.
- 4. And whereas under the provisions of section 25/26 of the Act, no person shall without the previous Consent of the State Board establish or take any steps to establish, any industry, operation or process or any treatment and disposal system or any extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land or bring into use any new or altered outlet for the discharge or sewage or trade effluent or begin to make any new discharge of sewage or trade effluent.
 - 5. And whereas under the provisions of section 20 of the Air Act, no person shall without previous consent of the State Board, establish or operate any industrial plant in an air pollution control area, which is likely to cause air pollution in environment.
 - 6. And whereas under the provisions of section 20 of the Air Act, no person discharge or cause or permit to be discharged the emission of any air pollutant in excess to the standards laid down by the State Board.
 - 7. And whereas the industry is being operated in the name and style of M/s Vardhman Chemicals, (herein after called as 'industry'), at Plot No. 20, Krishna Vihar-VI, Akera doongar, District -Jaipur and engaged in storage and trading of chemical.
 - 8. And whereas, your industry was inspected by R.O. Jaipur (North) official on 25/1/2018 in compliance of complaint received through Sampark Portel and unit has not adopted all requisite pollution control measures.
 - 9. And whereas, you are operating the industrial plant in Non-conforming /residential area and without obtaining prior consent to establish & operate under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.

- 10. And whereas, show cause notice for intended directions under section 33A of the Water (Prevention and Control of Pollution) Act, 1974 and 31A of the Air (Prevention and Control of Pollution) Act, 1981 was issued vide office letter dated 25/5/2018 for the reason mentioned therein and also you have failed to reply.
- 11. And whereas the State Board may, in exercise of the powers conferred upon it under the provisions of section 33A of the Water (Prevention and Control of Pollution) Act, 1974 & 31A of the Air (Prevention and Control of Pollution) Act, 1981 and in performance of its functions under the Acts, issue directions in writing to any person, officer or any authority and such person, officer or authority shall be bound to comply with such directions which includes the power to direct:-
- c) The closure, prohibition or regulation of any industry, operation or process.
- d) Stoppage or regulation of the supply of electricity or water or any other service.

The State Board further in exercise of the powers conferred upon it under section 33A of the Water (Prevention and Control of Pollution) Act, 1974 & 31A of the Air (Prevention and Control of Pollution) Act, 1981 and in performance of functions under the Acts and to prevent pollution, hereby directs you to, forthwith, close down your industry M/s Vardhman Chemicals, Plot No. 20, Krishna Vihar-VI, Akera Doongar, District - Jaipur. It may be noted that failure of compliance of these directions, is a criminal offence, punishable with imprisonment for a term which shall not be less than one year and six month but which may extend to six years and with fine under section 41(2) of the Water Act & 39 of the Air Act.

This bears the approval of the competent authority.
