Office Order

The State Board has implemented the system for online submission of the applications for consent and authorisation along with the deposition of applicable fee through online portal provided by the e-mitra. It has been observed that the deposition of fee through Demand Draft is causing delay in disposal of applications. Therefore, in order to reduce the delay in disposal of applications the Board has dispensed with the acceptance of DD for the online applications of consent, authorisation and registration.

- (i) From 5<sup>th</sup> October 2015 onwards the DD/cheques shall not be accepted by the e-mitra against the fee for consent, authorisation and registration applications submitted online.
- (ii) Only cash up to Rs 20,000/- (Rs. Twenty Thousand only) or online payments against the online submission of applications for consent, authorisation and registration will be accepted by the e-mitra.
- (iii) No consent fee for online applications shall be accepted by the Board in its office.
- (iv) The Accounts Section of RSPCB shall ensure that reconciliation of accounts between e-Mitra Society and the RSPCB shall be completed every fortnight.
- (v) Only balance fee for applications, which have been submitted in offline mode prior to the implementation of online application system, will be accepted by the State Board in its office, through DD only. The Regional Officers and the In-charge of Accounts cell at head Office shall ensure that except for fee pertaining to the offline applications no application fee shall be accepted at the State Board Offices.
