Office Order

In compliance of the direction of CPCB issued under the section 18 (1)(b) of the Water (Prevention and Control of Pollution) Act, 1974 and under section 18(1)(b) of the Air (Prevention and Control of Pollution) Act, 1981 the State Board issued direction to 17 category of highly polluting industries, GPI and CTDF's etc for ensuring establishment of online effluent/emission quality monitoring systems and their integration with the CPCB server and SPCB servers. The State Board established online Emission/Effluent quality monitoring server to facilitate entities required to comply with directions and a nominal fee as per table below was to be charged to recover the cost of the system.

The entities are to deposit the amount for a period of five years according to their capital investment. All such existing 17 category Highly Polluting Industries, CTDFs and Grossly Polluting industries that have not yet connected with the State Board server shall submit an additional 50% of the stipulated fee. The fee applicable to the any new industry/other than the industry covered under the CPCB direction shall be as per the table. It shall be mandatory to each unit covered, to deposit 5 year fee at the time of seeking connectivity.

It bears approval of the competent authority.
