Office Order

Modification in Mechanism for Environmental Management of Critically and Severely Polluted Area and considerations of activities/ projects in such areas in compliance to Hon'ble NGT order dated 23.08.2019 in the matter of O.A. No. 1038/2018.

Mechanism for environmental management of critically and severely Polluted Area and considerations of activities/ projects in such area in compliance to Hon'ble NGT order dated 23.08.2019 in the matter of O.A. No. 1038/2018 was issued vide office order no. F.14(99) corres/Plg(VI)/2709-2716 dated 26.12.2019. The additional Conditions under Air (Prevention & Control of Pollution) Act, 1981 at sr. no. i & ii under sub-clause "A" of para 2 of the office order dated 26.12.2019 are substituted by following:-

- (i) "Unit shall adhere to stringent air pollutants standards i.e. 80% of existing process emission standards in the CPA and 90% of existing process emission standards in case of SPA. However, in case of use of biomass as fuel the maximum permissible emission standards for Particulate Matter (PM) shall be 80 mg/Nm³ (Aim for achieving a level of 50 mg/Nm³)".
- (ii) "Only following fuels shall be used in boilers, thermic fluid heaters, furnaces and other utilities:
 - CNG/ PNG/ LPG/ Methane/ Hydrogen/ Bio-gas/ Bio-CNG.
 - 'Low sulphur Fuels' namely LSHS, very low sulphur fuel oil & ultralow sulphur fuel oil- for industrial purpose in metal smelting/ melting/ refining/ heating furnace & kilns. [Emission standards:-PM- 80 {mg/ Nm³} (Aim for achieving a level of 50 mg/Nm³), SO₂- 50 (mg/ Nm)³, NO_X- 50 (mg/ Nm)³.
 - Bio-mass briquettes. PM- 80 (mg/ Nm³) (Aim for achieving a level of 50 mg/Nm³)"

All other contents of the office order dated 26.12.2019 shall remain unchanged. However, for compliance of aforesaid modified conditions regarding permitted fuels the cut off date mentioned (as 10.07.2019) at sr. no. 5 of the office order dated 26.12.2019 shall be date of issue of this office order.
