Office Order

Delegation of powers to Regional Officers under Hazardous and Other Wastes (Management and Transboundary Movement) Rules 2016.

The State Board grants authorization to industries/projects/activities/processes under Rule 6 of Hazardous and Other Wastes (Management and Transboundary Movement) Rules 2016.

The State Board vide its earlier orders had delegated powers to Regional Officers to grant/refuse authorization applications in respect of textile industries connected with Common Effluent Treatment Plant (CETP) at Pali, Balotra, Bithuja, Jasol and Jodhpur and steel industries connected with Common Effluent Treatment Plant (CETP) vide office orders dated 14/07/2015 and 18/07/2019 respectively.

In addition to the above mentioned industries, the Regional Officers are hereby delegated powers to grant/refuse authorization to All industries /projects /processes/activities for which they have the powers to grant /refuse the consent to establish/consent to operate under Air (Prevention and Control of Pollution) Act, 1981 and Water (Prevention and Control of Pollution) Act, 1974.

However, the powers to revoke/cancel/withdraw authorization to All industries/projects/processes/activities irrespective of powers to grant/refuse authorization shall continue to vest with the RSPCB Head Quarter, as per the office order dated 10/01/2020.

This order shall come into force with immediate effect.
