Office Order

As per the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981, that all industries/ processes projects activities etc. shall obtain prior Consent to Establish and Operate before establishing/operating any industry/ process/ activity etc. However, there are instances where some of the industry processes/ activity etc. have not obtained consent due to certain reasons. In order to encourage such units to comply with the provisions of the Water and the Air Act, the State Board had is past introduced special dispensation schemes vide office order nos. F12(56-B)/Policy/Pig/RPCB/6024-55, 1415-48, 1162-1208, 584-628, 987-1021, 195-229, 1263-1296& 2276-2279 dated 22.02.2012, 30.08.2013, 08.03.2018, 14.09.2018, 30.07.2020, 01.02.2021, 01.07.2021 & 03.11.2023.

In continuation to that effort, the State Board, vide order no. F-14(56-B)/Policy/RPCB/1687-1697 dated27.11.2024, had issued an order to bring in a "Special Dispensation Scheme" for a period of 60 days starting from 01/12/2024 to 29/01/2025. Further, in continuation to State Board's office order dated 27.11.2024, the State Board has decided to extend the timeline for industries/establishments to apply under "Special Dispensation Scheme" till 31/03/2025. All other terms and conditions of the order dated 27.11.2024 shall be applicable.

This bears approval of the competent authority.
