Office Order

The State Board vide its office order dated 03.03.2023 and 10.04.2023 had laid down direction to industries to set-up new boilers based only on clean fuels with specific directions mentioned therein.

Subsequently, few representations have been received in the State Board in this regard. The matter has been reviewed and in order to pave way for future voluntary compliances, in partial modification to Office Order no. F.14(Adm-5)/RPCB/Project/V-III/92-137 dated 10.04.2023, usage of coal as a fuel in new boilers is also permitted. The applicable standards on various fuels will be as:

Fuel	Emission Standards
Biomass	PM-80 mg/Nm ³
Liquid Fuel	SO ₂ - 600 mg/Nm ³ at 3% dry O ₂ NO _x - 300 mg/Nm ³ at 3% dry O ₂
Gaseous Fuel	NO _x - 300 mg/Nm ³ at 3% dry O ₂
Coal	PM- 50 mg/Nm ³ SO ₂ -600 mg/Nm ³ at 6% dry O ₂ NO _x -300 mg/Nm ³ at 6% dry O ₂

In case, wherein stringent standards have been specified under Environment (Protection) Act, 1986 or by Commission for Air Quality Management in NCR sub-region and adjoining areas, Govt of India, or areas under Comprehensive Environmental Pollution Index (CEPI), the industry shall have to comply with the stringent standards.

However, in case of industries opting for usage of Biomass or coal will have to install Electrostatic Precipitator (ESP) or Bag House followed by Wet Scrubber or any other advanced technology to achieve the prescribed standards for air pollution control. In addition to this industries opting coal as fuel will have to install OCEMS and configure it with State Boards portal.

Rest of the directions as laid down vide office order No. F.14(Adm-5)/RPCB/Project/V-III/92-137 dated 10.04.2023 shall remain prevalent.

All Group In-charges/ Regional Officers of the State Board are directed to ensure compliance of the above. This order shall come into force with immediate effect.
