Order

- 1. Ministry of Environment, Forest and Climate Change vide Office Memorandum (O.M.) No. IA3-22/10/2022-IA.III dated 5th May, 2022 has issued a clarification with regard to non-requirement of Environmental Clearance (EC) amendment due to change in conceptual plan in building and construction sector.
- 2. The O.M. states that amendment of EC would not be required, if there is no change in built up area, floor area ratio (FAR), exterior spaces, green belts, parking, walkways, driveways, designated use of the building, number of dwelling units, height of the building, number of floors & basements and total excavation etc.
- 3. The O.M. states that in such a case the Project Proponent shall file an application in prescribed format on PARIVESH portal and obtain a self generated acknowledgement to this effect from the portal.
- 4. The O.M. further states that any such addition, alteration, modification in the conceptual plan, which result in increase in pollution of any type beyond the approved level in the EC would require fresh EIA/EMP.
- 5. The spirit of this O.M. is that the Project Proponent making minor changes, which do not result in increase of pollution, shall not be asked to get the EC revised before issue of Consent to Establish (CTE)/ Consent to Operate (CTO).
- 6. Cases are being received wherein there are minor changes in parameters prescribed in Para no. 2 above but such changes do not lead to increase in pollution beyond the approved level.
- 7. It has accordingly been decided that in case such minor change in parameters at Para 2 do not increase pollution of any type, such cases shall be processed for issue of CTE/CTO without insisting on a revision of EC/EIA/EMP.
