Office Order

Consequent to the amendment in the Part IV of the Schedule IV of the Rajasthan Water (Prevention and Control of Pollution) Rules, 1975 and Part IV of the Schedule of the Rajasthan Air (Prevention and Control of Pollution) Rules, 1983, following types sectors/ industries are added after the existing serial number 47 of the State Board Office Order no. F.12(PSC-1)RSPCB/PSC/360 dated 31.05.2016. These sectors/ industries will henceforth not require to obtain prior Consent to Establish and Consent to Operate under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981, but shall have to intimate the State Board prior to commissioning of industry or activity or operation or process:

S. No.	Type of Unit
48.	Automobile fuel outlet (Only dispensing)
49.	Bamboo & Cane product including Manufacturing from cane and bamboo of shopping bags, ornament boxes (Only dry operations)
50.	Book Binding
51.	Cottage Industry for manufacturing of pickle, papad, badi, mangodi etc.
52.	Manufacturing of handicrafts/decorative/fancy items only dry process with no source of air emissions
53.	Used Cooking Oil (UCO) collection centres
54.	Homestays/ Paying Guest Houses registered by Department of Tourism, Govt. of Rajasthan

The industries mentioned hereinabove at Sr no. 48, 49, 50, 51 and 52 appearing at S.No. 3, 7, 13, 22 and 43 respectively under the Green Category at Annexure C of the office order F.14(23)Policy/RPCB/Plg/ 153-189 dated 02.06.2020 and subsequent orders are hereby deleted.
