## Office Order

In partial modification to the Office Order dated 15.07.2020 regarding delegation of powers to Regional Officers, for grant, refusal and revocation of consent to Establish/ Operate under the provisions of the Water (Prevention and Control of Pollution), Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 is hereby amended as under:

- i. In the second line of the first Para of the Office Order, the phrase "grant or refusal" may be read as "grant or refusal or revocation".
- ii. In the table C, at Sr No 1, "Mining in Lease area less than 5 Ha.", may be substituted by the following:  
"Mining in Lease area upto 5 Ha."
- iii. In the Note no. D-3, the word "refused" shall be read as "refused or revoked".
- iv. The Note no. D-6, shall be deleted.

It is further clarified that the powers for grant, refusal and revocation of consent in Mining in Lease area more than 5 Ha vests with Head Office.

Rest of the delegation of power remains unchanged. This order shall come into force w.e.f 01.08.2023.
