In this context, it is brought to your notice that the notification dated 14.09.2006 & amended time to time issued by MOEF & CC, Govt. of India, New Delhi, the public hearing at the site or in its close proximity to be carried out for ascertaining concerns of local affected persons as per detailed procedure prescribed in the notification, according to which, the Distt. In order to comply the directions of Member Secretary, it is requested to decide the date, time and venue for the conduct of public hearing keeping in view that the entire process of public hearing is to be completed within in 45 days from the date of receipt of application from the project proponent. The notice of public hearing has to be published in two national newspapers at least 30 days before the day of public hearing.
