- 2. For Sampling and Analysis Work of regulatory parameters like PM₁₀, PM_{2.5}, SO₂, NO₂ and metals (Pb, Ni, and As in PM₁₀) CPCB guidelines volume-I may be adopted. For metal/elements analysis in PM_{2.5}(Al, Ba & Fe, in PM_{2.5}) (PTFE filter), EDXRF is the best option however other suitable method (ICP-MS/ICP-AES) may also be adopted.
- 3. The Bidder shall submit the proof of (ICP-MS/ICP-AES) or EDXRF with copy of these instrument purchased by the firm and all above parameters are in their valid SCOPE, as per NABL/MOEF & CC with present NABL calibration certificate that instrument as a mandatory document.
- 4. Bids must be enclosed in a properly sealed envelope.
