- 1 Air quality monitoring shall be carried out for consecutive 15 days commencing from 20th October, 2019 to 3rd November, 2019 for PM10, PM2.5, SO2, NO2 and metals (Pb, Ni and As in PM10) selected metals/elements (Pb, Ni, As, Al, Ba, Fe, Sr in PM2.5) to assess the impact of firecracker bursting during Deepawali festival.
- 2 For analysis of regulatory parameters like PM10, PM2.5, SO2, NO2, and metals (Pb, Ni, and As in PM10) CPCB guidelines volume- I may be adopted. For metal/elements analysis in PM2.5 (PTFE filter) EDXRF is the best option however other suitable method (ICP- MS/ICP-AES) may also be adopted.
- 3 Bids must be enclosed in a properly sealed envelope.
- 4 The Bidder shall sign the Bid form at each page and at the end in token of acceptance of all the terms and conditions of the Bid.
- 5 Rate shall be written both in words and figures. There should not be errors and/or over-writings, corrections if any, should be made clearly and initialed with dates. The rates should mention element of the all the Tax.
- 6 All rates quoted must include all types of charges.
- 7 Inspection: (a) The Board Officers or his duly authorized representative shall at all reasonable time have access to the laboratory premises and shall have the power at all reasonable time to inspect and examine the samples and procedure of analysis.
