## Office Order

Ministry of Environment, Forest and Climate Change (MoEF & CC) has issued notification on 12.08.2021 to ban use of identified Single Use Plastic (SUP) items with effect from 01.07.2022. Subsequently, Department of Environment and Climate Change (DOE&CC), Government of Rajasthan has issued order dated 20.06.2022 to ban some more SUP items i.e. **artificial flowers, banners, flags, flower pots and PET bottles** in all the State Government offices.

In view of the above, it is hereby directed that:

1. SUP items banned vide MoEF & CC notification dated 12.08.2021 and DOE&CC order dated 20.06.2022 shall not be used in State Board's Head Quarter and the Regional Offices.
2. In addition to above, purchase/use of **all type of plastic folders for carrying documents/papers and plastic coasters, stationery items etc.** shall also be prohibited in State Board's Head Quarter and the Regional Offices.

This bears approval of the competent authority.


