NOTIFICATION

In exercise of the powers conferred by section 38 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act No. 7 of 2014), the State Government hereby makes the following scheme further to amend the Rajasthan Street Vendors (Protection of Livelihood and Regulation of Street Vending) Scheme, 2017, namely:-

- 1. Short title and commencement.- (1) This scheme may be called the Rajasthan Street Vendors (Protection of Livelihood and Regulation of Street Vending) (Amendment) Scheme, 2023.
- (2) It shall come into force on and from the date of their publication in the Official Gazette.
- 2. Amendment of clause 5.- In item (v) of clause 5 of the Rajasthan Street Vendors (Protection of Livelihood and Regulation of Street Vending) Scheme, 2017, hereinafter referred to as the said scheme, for the existing expression "an undertaking", the expression "declaration" shall be substituted.
 - 3. Amendment of clause 9.- In clause 9 of the said scheme,-
 - (i) in sub-clause (1), the existing expression "on payment of a fee of rupees five hundred" shall be deleted; and
 - (ii) in sub-clause (2), the existing expression " on payment of a renewal fee of rupees five hundred" shall be deleted.
- 4. Amendment of clause 13.- In sub-clause (1) of the clause 13 of the said scheme, the existing expression ",along with renewal fee of rupees five hundred" shall be deleted.".
- **5. Amendment of form-A.-** The existing form-A appended to the said scheme shall be substituted by the following, namely:-
