Subject: Direction by Hon'ble Justice Deepak Maheshwari for Solid Waste Management

Ref: Minutes of Meeting by RSPCB under chairmanship of Hon'ble Justice Deepak Maheshwari dated 01.07.2019

As you are aware State Level Committee for Solid Waste Management in OA 606/18 has been constituted in the chairmanship of Hon'ble Justice Deepak Maheshwari.

Hon'ble Justice Deepak Maheshwari directed to comply all the municipality on the below following points.

1. All Municipality shall **deliver the Plastic carry bags** to district/division headquarter as directed vide letter 33775 dated 27.06.2019. It is mandatory for all District/ Division as mentioned in previous letter to send the seized carry bag before 20th July 2019 and send the compliance report to DLB.
2. All ULB's shall prepare and send the list/Name with address of all **Bulk waste generator** in their municipal area before **20th July** to LSG. All ULB shall update the list as per format attached on Google Drive (swmdlb@gmail.com).
3. BWG shall treat their own waste through in-house composting and for collection of dry waste user charges shall be levied on BWG. ULB shall take strict action as per bye laws for non-compliance of Solid Waste Management Rules by BWG.
4. All ULB's shall contact to Industries for helping them in IEC activity under their CSR activity.
5. ULB's shall contact Sarthak NGO/other NGO's for development of MRF in their area.
6. ULB's shall send the compliance of **ill managed ward** as mentioned vide letter 33616 dated 27.06.2019 before **15th July 2019** and the monthly progress shall be update on Google Drive. Continuous monitoring with photography/ videography shall be done for next 4 months to make that ward into modal ward (swmdlb@gmail.com).

7. ULB's shall plan extensive IEC program and spread awareness in their area with the help of NGO/ Electronic Media including School, Colleges, Bal Sabha etc.
8. ULB's shall emphasis on Segregation, timely Door to Door Collection, Plastic Waste Management
9. ULB shall demarcate the area for C&D waste processing and disposal along with geo tagging of collection points and send the report before 20th July 2019.
10. All ULB's shall send the compliance report of 18 Points as suggested by NGT in the format uploaded on Google drive (swmdlb@gmail.com).
11. As Hon'ble Justice Deepak Maheshwari visited Bharatpur, Alwar, Rajgarh, Gangapurcity, Behror, Nathdwara, Udaipur, Dungarpur and Mount Abu, the compliance report from them on NGT 18 Points, Ill managed ward and the direction given by them during their visit shall be submitted to DLB within 7 Days.

You are directed to send the compliance report along with the nodal officer details in next 7 days on cedlbp@gmail.com. For continuous monitoring the folder and formats (Ill managed ward, Bulk Waste Generator, Nodal Office contact details) are uploaded to Google Drive SWMDLB@GMAIL.COM.
