In exercise of the powers conferred by section 337 read with section 335 of the Rajasthan Municipalities Act, 2009 (Act No.18 of 2009), the State Government hereby makes the following rules further to amend the Rajasthan Municipalities (Class IV Service) Rules, 1964, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Municipalities (Class IV Service) (Amendment) Rules, 2021.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

- 2. Insertion of rule 9A and 9B.- After the existing rule 9 and before the existing rule 10 of the Rajasthan Municipalities (Class IV Service) Rules, 1964 the following new rule 9A and 9B shall be inserted, namely:-
- "9A. Disqualification for appointment.- No candidate shall be eligible for appointment to the service who has more than two children on or after 01 April, 2022:

Provided that,-

- (i) the candidate having more than two children shall not be deemed to be disqualified for appointment so long as the number of children he/she has on 01 April, 2022, does not increase.
- (ii) where a candidate has only one child from earlier delivery but more than one child is born out of a single subsequent delivery, the children so born shall be deemed to be one entity while counting the total number of children.
- (iii) while counting the total number of children of a candidate, the child born from earlier delivery and having disability, shall not be counted.
- (iv) any candidate who performed remarriage which is not against any law and before such remarriage he is not disqualified for appointment under this rule, he/she shall not be disqualified if any child is born out of single delivery from such remarriage.
- (v) this rule shall not be applicable to the appointment of a widow of the deceased employee on compassionate ground.

9B. Disqualification for Promotion.- No candidate shall be considered for promotion for three recruitment years from the date on which his promotion becomes due, if he/she has more than two children on or after the 01 April, 2022:

Provided that,-
