Sub:-"Nagar Van" Scheme-Circulation of Implementation Guidelines.

Ref:-Deputy Inspector General of Forests (NAEB) letter no. 1-4/2020-B1(NAEB) dt. 04.08.2020 and E.1-4/2020 B I(NAEB) dt. 30.07.2020.

It is informed vide referred letters that the scheme 'Nagar Van Yojana-2020' announced by Hon'ble Minister MEFCC on 5th June, 2020 (during World Environment Day Celebrations) aims at creation of 200 'city forests' primarily on forest land, in urban cities having a Municipal Corporation or Municipalities, over a period of five years, within the limits of the cities or on its fringes.

- The primary objective is to create a forested area within the city, to protect the forest land from further degradation and encroachments and provide a healthy and wholesome living environment for the residents of the city.
- Each Nagar Van will be created over a maximum area of 50 ha of forest land and a grant of upto Rs. 2.00 crore will be provided for developing the Nagar Van of that extent. Minimum area over which Nagar Van can be created shall be 10 ha.
- The funds for the above purpose will be released to State Forest Development Agencies (SFDAs), from the corpus of National CAMPA Funds.
- The grant released by Ministry will cover the cost of fencing to protect the land, cost of water conservation/rain water harvesting facilities, etc. For meeting other requirements like plantation and other components, alternate resources may be utilized.
- The scheme is proposed to be implemented in a collaborative mode involving various other departments and agencies. The Municipal Corporations and Urban Local Bodies will play a crucial role in this initiative by providing vital support through financial and other supplements.
- The guidelines of the scheme are attached with this letter for your information and necessary action. The feasible encroachment free land areas for development of 'Nagar Van' has to be identified and informed to Gol through SFDAs. Accordingly, you are directed to identify suitable encroachment free lands in urban areas for this schemes and send the information of identified lands in attached format by 20.08.2020 positively.
