

Notification

In exercise of the powers conferred by section 5 of the Rajasthan Lakes (Protection and Development) Authority Act, 2015 (Act No. 5 of 2015), the State Government hereby specifies that for protection and development of the Soorsagar Lake situated in village Bagan, Tehsil Jodhpur, District Jodhpur.

- (a) Following activities shall be prohibited in the geographical boundaries of the Soorsagar Lake and in its protected area:-
- (i) Removal, excavation, grading or degrading of soil, sand, gravel, minerals, organic matter or material of any kind except for lake preservation/conservation;
 - (ii) Dumping, discharging or filling with any material except for the preservation/conservation of the lake;
 - (iii) Draining, flooding or disturbing of the water level or water table;
 - (iv) Driving of pilings;
 - (v) Placing of obstruction affecting inflows, overflows, storage, navigation, safety and security etc;
 - (vi) Destruction or alteration of wetlands vegetation through clearing, harvesting, shading, intentional burning, planting that would alter the character of a regulated wetland;
 - (vii) Activities that result in a significant or adverse change in water temperature, a significant or adverse change of physical or chemical characteristics of wetland water sources including quantity or the introduction of pollutants; and
 - (viii) Discharge of drainage.
- (b) Following activities may be carried out in the geographical boundaries of the Soorsagar Lake and its protected area after obtaining permission from the Rajasthan Lakes Development Authority :-
- (i) Boating for tourists;
 - (ii) Adventure water Sports;
 - (iii) Other water games;

- (iv) Bird sanctuary;
- (v) Activities related to conservation or preservation of soil, water, vegetation, fish, shellfish and other wild life that does not entail changing the structure or functions and character of the existing wetland adversely;
- (vi) Outdoor recreational activities including fishing, bird watching, hiking, boating, horse riding, swimming, canoeing, and bicycling etc;
- (vii) Maintenance of drainage ditches to original specifications;
- (viii) Carrying out studies, survey, investigation, research, etc;
- (ix) Educational, scientific research and use of nature trails;
- (x) Installation of navigation aids and boundary markers;
- (xi) Activities for minimal soil disturbance for site investigative work necessary for land use application submittals such as surveys, soil logs, percolation tests and other related activities. In every case, wetland impacts shall be minimized and disturbed areas shall be immediately restored etc;
- (xii) Ecotourism sans creating of concrete jungle around the lake;
- (xiii) Activities related to maintenance, safety & protection of lake and associated structure; and
- (xiv) The construction, re-construction, demolition, expansion or alteration of any structure including driving of piles considered expedient for the protection, safety and improvement of the lake and its associated structures;

This notification is final until modified or withdrawn by the State Government.



Notification


In exercise of the powers conferred by section 4 of the Rajasthan Lakes (Protection and Development) Authority Act, 2015 (Act No.5 of 2015), the State Government on the recommendation of the Rajasthan Lakes Development Authority, hereby declares and specifies lake area along with the boundaries of Soorsagar Lake and geographical area around it as a protected area situated in villages Bagan of Tehsil Jodhpur, District Jodhpur as shown in map and details of khasara numbers given below :-

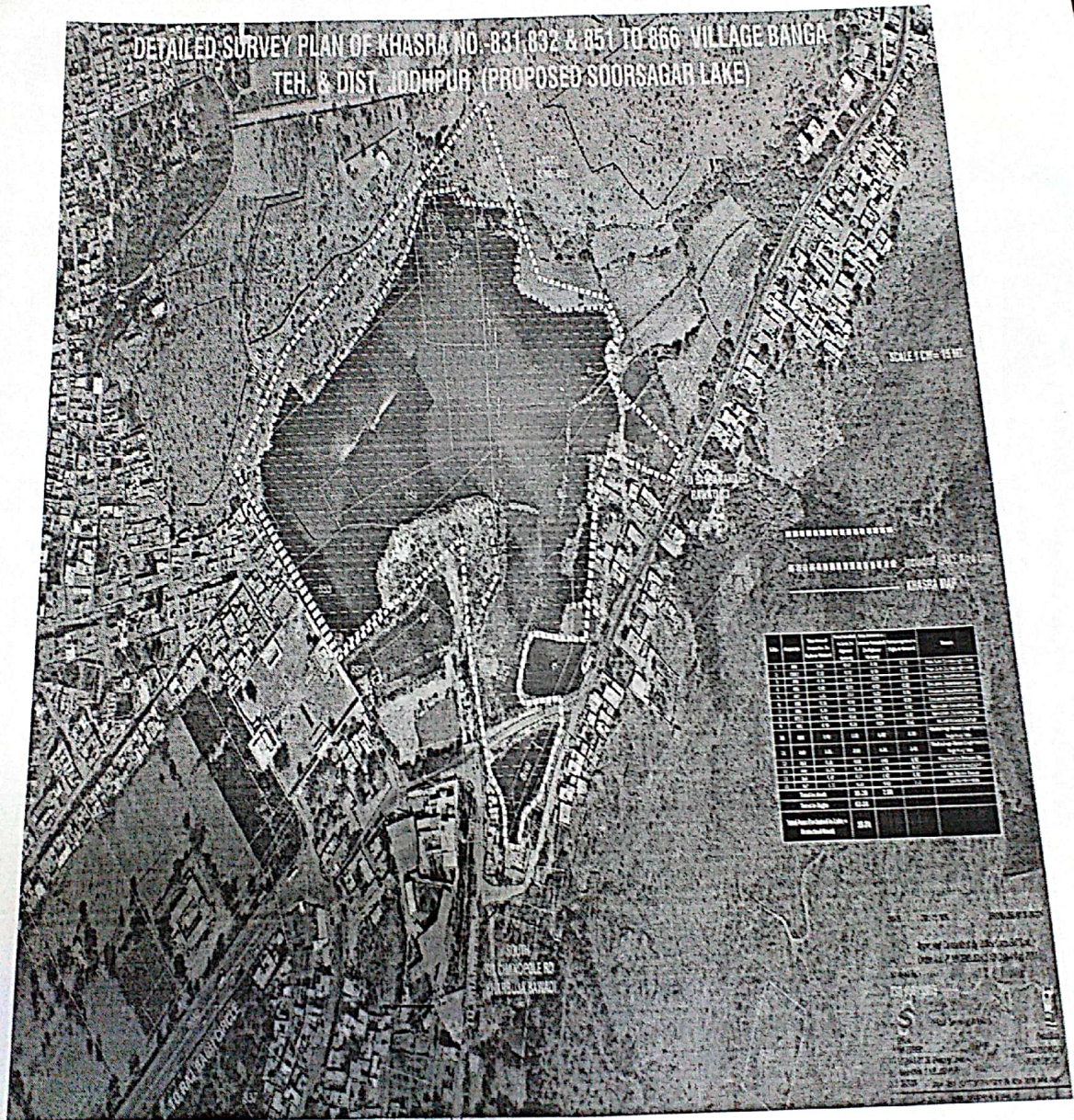
