### विज्ञप्ति

मण्डल मुख्यालय में वर्ष 2012-13 हेतु 20 टैक्सी वाहन लगाने हेतु वाहन मालिको, फर्म, ट्रेवल एजेन्सीज से रजिस्टर्ड टैक्सी वाहन, जो स्वयं के नाम से रजिस्टर्ड हो से आवेदन पत्र आमंत्रित किये जाते है। आवेदन पत्र के साथ वाहन संबंधित कागजों व टैक्सी वाहन चालक के लाइसेन्स की छाया प्रति संलग्न कर दिनांक 13-04-12 के दोपहर 3.00 बजे तक प्राप्त की जाएगी। वाहन 5 वर्ष से पुराना नही होना चाहिए। इण्डिका वाहन हेतु 1500 कि.मी. की दरें रु.15000/- प्रति माह एवं इण्डिगो या समकक्ष ए.सी. वाहन की 1500 कि.मी. की दरें रु.18400/- प्रति माह देय होगी। मण्डल कार्य से माह में 1500 कि.मी. से अधिक वाहन चलाने पर क्रमशः 6रु.व 7.60 प्रति कि.मी.की दर से सक्षम स्वीकृति के पश्चात् भुगतान किया जावेगा। आवेदन पत्र के साथ प्रति टैक्सी इण्डिका वाहन हेतु रु.3600/- एवं इण्डिगो या समकक्ष वाहन हेतु रु. 4416/- का ड्राफ्ट जो राजस्थान आवासन मण्डल जयपुर के पक्ष में अमानत राशि के रूप में लगाना होगा। विस्तृत शर्तों के बारे में मुख्यालय स्टोर से कार्य दिवस में कार्यालय समय में जानकारी प्राप्त की जा सकती है या राजस्थान आवासन मण्डल की WEBSITE: WWW.RHBONLINE.RAJASTHAN.GOV.IN पर उक्त जानकारी देखी जा सकती है। आवेदन पत्रों पर अन्तिम निर्णय लेने का अधिकार राजस्थान आवासन मण्डल को होगा।

## AGREEMENT

An agreement made this .....day of .....between.....

(here in after called "**the approved contractor**", which expression shall, where the context so admits, be deemed to include his heirs, successors, executors and administrators) of the one part and the Rajasthan Housing Board. (hereinafter called "the Board" which expression shall, where the context so admits, be deemed to include his heirs, successors in office and assigns) of the other part.

Whereas the approved contractor has agreed with the Board to provide vehicles on hiring basis to the .....of the State of Rajasthan at its Office. and Whereas the approved contractor has deposited a sum of Rs.....in Cash/Bank/Draft/Challan No./Banker's cheque No.....dated.....as a security deposit

Now these present Witness:

- (1) The condition of the tender and contract appended to this agreement will be deemed to be taken as part of this agreement and are binding on the parties executing this agreement.
- (2) Letters Nos.....received from tenders and Letters Nos.....issued by the Board and appended to this agreement shall also part of this agreement.
- (3) The Board do hereby agree that if the approved contractor shall duly provide the vehicles on hiring basis in the manner aforesaid observe and keep the said terms and conditions, the Board will through.....pay or cause to be paid to the approved contractor at the time and the manner set forth in the said conditions.

The following conditions will be applicable:-

1. The vehicle shall be insured and registered under taxi quota with RTO/registering authority and it shall be the model of the year.....( not be more than 5 years old) and onwards. The vehicle shall be completely fit and be in good condition.
2. The approved contractor is responsible for all taxes, permit, insurance, service tax, fitness, timely obtaining pollution control certificate, legal claims, challan for violation of Rules/laws and all legal matters pertaining to vehicle and driver.
3. The expenditure of toll tax and parking charges, if any, will be reimbursed by the Board.
4. The vehicle as far as possible, shall be parked in the office premises, but at the risk of the approved contractor.
5. The contractor would be required to provide a plate on each vehicle stating that the vehicle is "ON RHB DUTY" The plate will be such type that it can be removed by pulling it out of its frame. When the vehicle is going off duty, this plate shall be removed and kept in the custody of Office-in-charge.
6. The driver shall be dressed neatly and also keep the vehicle neat and clean and behave properly with the officers using the vehicle.
7. Generally duty time of the vehicle will be from...9.....a.m...to...8.....p.m. or as desired by the user officer.
8. Rate quoted by the contractor shall be valid for one year (from.....to.....)

However, the period of agreement may be extended for next 6 months, if both the parties agree.



9. Distance and time shall be calculated from the duty point.
10. Hired vehicle can be used anywhere in the state. in case the night halt at the place other than that of headquarter,a sum of Rs...150..per night shall be paid for the driver.
11. Payment shall be made@ Rs .....per month per vehicle for the maximum 1500. Km. Payment for Kms. run in excess of the prescribed ceiling,wil be made @ Rs.....per Km.
12. vehicle shall be provided by the approved contractor as per demand of the office.The department will inform the approved contractor for providing vehicle in advance.
13. If a vehicle is not provided by the approved contractor in time,a penalty of Rs...750/..- per day per vehicle shall be imposed on the approved contractor and the Board may hire other vehicle. The payment of additional charges,if paid,will be recovered from approved contractor.
14. If a vehicle stands on road,the approved contractor shall provide another vehicle in time at his own cost.
15. During the course of journey,original papers of the vehicle,e.g. Registration certificate,fitness certificate,permit of jurisdiction and other relevant papers must be in the vehicle in the custody of the driver.
16. Maintenance charges of the vehicle,POL etc. will be borne by the approved contractor.
17. Payment: Approved contractor shall submit the bill in duplicate along with log sheet duly verified by the officer-in-charge.
18. Liabilities: All types of liabilities including accidental claims,if any,shall be borne by the approved contractor.
19. All disputes arising out of this agreement and all questions relating to the interpretation of this agreement shall be decided by the Board and the decision of the Board shall be final.
