**CIRCULAR**

**Sub: Notice & signage board on work sites, marking on equipments supplied under National Lake Conservation Plan.**

It is desired that the requisite information related to the execution of works and at different work sites must be displayed mentioning various components of activities / project cost, duration etc. together with the benefits to be provided to the peoples.

The Implementation Units of NLCP are directed to issue necessary directions to all the contractors and the field engineers and the compliance should be ensured by him within seven days. He should ensure the display of desired information & monitor the compliance of targeted deliverables on regular basis.

The language of signage has been standardized in the enclosed format at Annexure "A" for Notice & Signage Boards on work sites and Annexure "B" & "C" for marking on equipments supplied under NLCP, on the following suggested sizes. The sizes are indicative and can be changed as per site conditions.

1	Major Roads/ Entry Roads/ Flyovers/ STPs etc.	10'x 6' or 8'x 5'
2	Pumping stations; Heritage works; de-silting works; Lake front development works; catchment area treatment works etc.	8'x 5' or 6'x 4'
	Beautification works; Improvement of feeders/ inflow channel works; De-weeding; sewer lines works; aquaculture/ public awareness/ works etc.	6'x 4' or 5'x 3'
4	<b>Markings on equipments supplied under NLCP:</b>	
	i. On Floating Fountains, De-weeding machines etc	5'x 3' or 3'x 2'
	ii. On refuse Compactor, 4 wheeler bin carriers etc	5'x 3' or 3'x 2'
	iii. On cycle rickshaw, push carts, 1.1 cum garbage collection containers etc.	2'x 1.5' or 1.5' x 1.0'
	iv. On FRP bins (70/40 lit) etc	1.5' x 1.0' or 1'x0.75'
	Caution notice, diversion boards etc.	3'x 2' or 2'x 1.5'

The project information should also be displayed on a suitable size notice board in the Implementation Unit office.
