**Jaipur, March 8, 2019**

**F.No. 25564** .- In exercise of the powers conferred by section 95 read with sub-section (4) of section 3 and section 4 of the Jaipur Water Supply and Sewerage Board Act, 2018 (Act No. 24 of 2018), the State Government hereby makes the following rules, namely: -

**1. Short title and commencement.-** (1) These rules may be called the Jaipur Water Supply and Sewerage Board (Constitution and Condition of Service of Non-Official Members of the Board) Rules, 2019.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

**2. Definitions.-** (1) In these rules, unless the context otherwise requires,-

- "Act" means the Jaipur Water Supply and Sewerage Board Act, 2018 (Act No. 24 of 2018);
- "Board" means the Jaipur Water Supply and Sewerage Board constituted under section 3 of the Act;
- "Government" means the State Government of Rajasthan; and
- "State" means the State of Rajasthan.

(2) All words and expressions used but not defined in these rules, unless the context otherwise requires, shall have the same meaning as respectively assigned to them in the Act.

**3. Constitution of the Board.-** The Board shall consist of the following, namely: -

**4. Allowances to Non-official Members.-** (1) The Non-official Members of the Board shall be entitled to the allowances specified in the table below:-
