- India has received financing from the Asian Development Bank (ADB) towards the cost of Rajasthan Urban Sector Development Program. Part of this financing will be used for payments under the contract named above. Bidding is open to all eligible bidders from eligible source countries of ADB.
- 2. Local Self Government Department represented by Rajasthan Urban Infrastructure Development Project (RUIDP); hereinafter referred to as the "Employer"), invites online bids from cligible bidders for "Construction of Works of Water Supply Distribution Network Improvements with house service connections for nonrevenue water reduction and continuous water supply; Providing Sewer Network with House connections and construction of STP and maintenance of the system for 10 years at Tonk". Scope of work includes rehabilitation and expansion of existing water distribution infrastructure to achieve continuous pressurised water supply, construction of sewerage system and operation, maintenance and management of the water supply and sewerage system for 10 years on performance based. Bidder will submit online bids as per instructions in following paragraphs.
 - 3. To be qualified for the contract package, the bidder should as a minimum meet the following requirements:
 - a) Average annual construction {with or without Operation and Maintenance (O&M)} turnover of INR1500 million or US\$ 25 million calculated as total certified payments received for contracts in progress or completed, within the last 3 years (Financial Year 2011-12, 2012-13 & 2013-14 or as per International practice);
 - b) Participation in at least (i) one contract in water supply sector where the value of the completed or substantially completed work exceeds INR 800 million and (ii) one contract in sewerage sector where the value of the completed or substantially completed work exceeds INR 1200 million or two contracts in sewerage sector where the value of the each completed or substantially completed work exceeds INR 600 million or three contracts in sewerage sector where the value of the each completed or substantially completed work exceeds INR 400 million, within the last 7 years (from 1 April 2007 to date); and
 - c) Meet other financial and experience requirements as indicated in the Bidding Document.

However for complete eligibility and qualification requirements, interested bidders should refer to the Bidding Document.
